- 1. Notes of NPSG July 17th draft minutes: NPSG: agreed with minutes.
- 2. Matters Arising and Action Points discussed:

Item 3: Examiner Selection: PT talked through the two IPe examiners detailed in his document (see attachment) and the EDDC procurement process. PT recommended examiner Jill Kingaby.

NPSG: Accepted Jill Kingaby to be their appointed examiner.

Item 6: ETC Decision: NP implementation Strategy: This was taken to ETC Meeting on Monday 6th August 2018; Item c18/110 Outcome was:

Neighbourhood Plan Steering Group

The notes of the meeting dated 17th July, 2018 were accepted. It was agreed that once the Plan had been submitted for examination the NPSG would draft an Implementation Strategy and the Town Council would review and agree this in an Extra-Ordinary meeting prior to the plan being made.

- 3. Finance: Consultants have incurred extra hours this was due to:
- the Submission document not being completed in time for them to work with.
- The acceptance of the new NPPF July 2018

NPPF discussion: The Exmouth Neighbourhood Plan Submission Document will not need to be altered in line with the 2018 document :

- NPPF 2012 citation on page 13 does not differ much from the July 2018 version.
- Exmouth is within new legislation which requires all Neighbourhood Plans submitted from January 2019 onwards have to use and work with the July NPPF. PT supported the above 2 bullet points.

NPSG agreed that the Exmouth NP submission document remains as is and recommended that the NP is regularly monitored in relation to the NPPF. (July 2018)

PT provided information on modifications of Neighbourhood Plans and that there is funding available for this. Action :PT to provide funding guidelines and details on the modification process and to confirm time lines (five years).
