## Yestermorrow Competition Results

With help from donations, we were able to give away three copies of member Noel Harrower's new novel 'Yestermorrow'. A good, uplifting read, it demonstrates a faith in ability to surmount difficulties by coming together as a community.

I have to be honest and admit that I don't remember who the winners were but here are the Q&A all of which are relevant to the subject of Noel's novel:

- Q1 What is the name of the UN body tasked with investigating anthropogenic climate change? *Ans: IPCC, Inter-governmental Panel on Climate Change*
- Q2 what does anthropogenic mean? *Ans: Originating in human activity*
- Q3 What temperature increase is the IPCC now recommending as a limit to what our civilisation can cope with? *Ans: 1.5 deg C*

- Q4 “Yestermorrow” is a story set in an East Devon coastal town between the years 2035 and 2099, although the place names and some of the geography are changed. On which real town does Noel Harrower base the story? *Ans: Exmouth*
- Q5 In his book, Noel has rising tides destroy a neighbouring coastal village. What steps are being taken now in Exmouth to prevent the flooding of the River Exe and of the seafront? *Ans: the environment Agency will be making improvements to revetments and raising walls by up to 0.5m, within the next five years. Note, there is a further commitment to more extensive wall-raising by 0.5-1.2m between 2030 and 2110 to keep pace with climate change.*

## **East Devon and Blackdown Hills Landscape Character Assessment**

East Devon District Council, working with partners commissioned Fiona Fyfe Associates to produce a new Landscape Character Assessment and are now consulting on a draft report.

## COLP

Despite our urging more immediate action, the Town Council have decided that the COLP Terms of Reference, which need updating, will be reviewed only on completion of the Exmouth Neighbourhood Plan Implementation Strategy, which cannot be decided until NP adoption. As for that process, we were advised in November that the final steps are to:

1. secure the approval of the Examiner [might well have been secured already],
2. secure the approval of the District Council,
3. get the support of Exmouth voters in a referendum.

The town is on track towards a referendum next March. Since community organisation participation in the NP implementation is necessary, it will not surprise me if COLP does not continue in its current form and remember that as currently constituted, COLP is jointly owned by the groups and the TC, the NP implementation will be wholly owned by the TC!

## Plastic Waste Reduction Campaigns

In my last newsletter, I mentioned briefly that member Cllr. Tim Dumper was successful with his motion to the Town Council to consider practical actions to reduce plastic waste.

Following is an extract from the TC minutes of 26 November:

*C18/148. Review of the motion from Councillor T Dumper to set up a working party to consider practical actions to reduce plastic waste and implement them by working with other groups. Both Councillor L Elson and Councillor S Gazzard confirmed that their groups were in support of the motion and that like local businesses the Town Council should move forward with acting to reduce use of plastics.*

*Councillor T Dumper, proposed, seconded by Councillor L Elson, that the Town Council sets up a working party to consider practical actions to reduce plastic waste and implement them by working with other groups.*

*RESOLVED that the Town Council sets up a working party to consider practical actions to reduce plastic waste and implement them by working with other groups.*

*The Chairman confirmed that Councillors R Masding, T Dumper, K Norton and B De Saram had expressed an interest in joining the working party.*

So is Exmouth on its way to becoming a single-use plastic town? Lets congratulate Tim and help the Councillors make a real difference.

## DCC Climate Emergency?

As urged by Claire Wright, I wrote as follows to our DCC Councillors in support of a Climate Emergency motion tabled by Councillor Jacqi Hodgson.

*'Dear Councillors Scott & Trail*

*Today Councillor Jacqi Hodgson will propose a motion to Full Council to declare a climate emergency. I urge you to support it.*

*The recent report from scientists on the IPCC makes clear that life on our planet faces an existential crisis; the worst effects of which are yet avoidable by achieving rapid and dramatic reductions in greenhouse gas emissions.*

*I commend Devon County Council for its foresight and leadership on addressing climate change. In particular the signing of the Nottingham Declaration on Climate Change in 2014 which underpins the Council's strategies, action plans, public statements and advice to businesses, residents and parish councils. However, current plans and actions are not enough; we need far more ambitious action and we need it NOW.*

*I therefore call on you to back the Climate Emergency motion on Thursday which will commit Devon County Council to make the county of Devon carbon neutral by 2030, taking into account both production and consumption emissions; call on Westminster to provide the powers and resources to make the 2030 target possible; work with other governments both within the UK and internationally to determine and implement best practice methods to limit global warming to less than 1.5°C; continue to work with partners across the county and region to deliver this new goal through all relevant strategies and plans; and report to Full Council within six months with the actions the Council will take to address this emergency.*

*Thank-you. I look forward to hearing from you and trust you will be able to assure me of your support for this motion. '*

I later received the following updates from Councillor Richard Scott:

*'The motion has been referred to Cabinet for consideration.'*

and from Cllr Jeff Trail BEM.

*'Many thanks for your email. Cllr Scott and I will listen to all arguments relating to climate and vote accordingly if and when required.'*

## IPCC Report and You

In their latest report, the IPCC scientists are really urging action to limit global temperature rise to 1.5 deg C. New in this report is a direct address to consumers, i.e. You and me.

To summarise Here's what consumers can do:

\*Transportation: travel less, with a preference shift to more sustainable choices: car-sharing, hybrid and electric cars. The report also looks at using more efficient modes of travel, e.g. swapping cars, trucks and planes to buses and trains.

\*Buildings: the IPCC suggests that people shift to more sustainable behaviour when it comes to their homes, for example using smart thermostats or more efficient air conditioners (this is for Americans, lets hope the UK does not go down the road of ubiquitous A/C!).

\*Diets: the IPCC's narrative suggests that people need to consume about 30% less animal products. Eating less meat is one of a number of mitigation strategies suggested by the IPCC to overhaul agricultural and land-use practices, including the protection of forests. The livestock sector is estimated to account for 14.5% of greenhouse gas emissions globally, more than direct emissions from the transport sector.

## **Sustainable Exmouth**

I have notes from members Andy Lock and Anne-Marie Culhane who attended, along with 50 others, the recent meeting with Wayne Hemingway. Thanks very much to them.

I can share their report with any member who asks.

Hemingway presented his survey results (available on his Website). The research provided direction to a design approach for the execution of any ideas which are contemporary, eclectic, and environmentally sensitive. The design brief is broadly intended to reflect the local topography, sea-front location and use of 'natural' materials wherever possible.

Hemingway shared 12 concepts which were presented as highly finished designs. He emphasised however that these are for consideration only and that at THIS STAGE the discussion remains entirely open and not only are new ideas welcome but that the designs themselves will require further consideration as the entire plan for the site evolves.

It would appear however that nothing truly innovative has been considered, all the possibilities mentioned can likely be found elsewhere and thus our report's note of a lack



of vision seems justified. Seems that Tourist Resort marketing is the intention and facilities that would really please us did not get much support. Our yardstick must remain:

'A FORWARD-LOOKING ECO-DESIGN THAT FEATURES ALL THE LATEST THINKING IN MATERIALS, CONSTRUCTION AND RENEWABLE UTILITIES.'

We can yet revert to Hemingway with proposals but he was clear that a commercial case must be made out for the profitability of the whole.
